TO ALL FOOD VENDORS:

- I must prepare my food at a restaurant/established (church, temple) that has a food permit from the local Board of Health. (I am not permitted to prepare the food at home). I will bring a completed copy of the food permit.
- I shall keep my booth area clean and safe at all times.
- I am not permitted to change my assigned location or exceed my assigned boundaries (booth will be assigned based on a lottery system that will be drawn at the first Booth Orientation; to Board of Director's discretion)
- I shall finish setting up by 10:00 AM and clean up and remove all equipment's from my booth area by 7:00 PM.
- I shall receive one 'Drop-Off/Parking Permit' for my vehicle.
- I shall sell only the items that are listed on this application form. (This will be strictly enforced and failure to adhere may result in the closing of my booth).
- The LSAWF, Inc. is not responsible for any damages/losses.
- Booth inspectors will be monitoring all activities to ensure compliance; any violations may result in the closing of my booth.
- I shall provide my own tables, chairs and tent (10ft x 10ft).
- If my organization is a Non-Profit, I will submit a letter (on appropriate letterhead) signed by the president and clerk acknowledging that all proceeds will go to the organization. I will bring this letter when I attend the Booth Orientation.
- I must attend one of the Booth Orientation Sessions with the City of Lowell Health Department which will help me understand my roles and responsibilities. Orientation dates will be announced later.
- The location of the orientation will be announced later. This orientation is mandatory for all food vendors. If I cannot attend the orientation, I must make other arrangements to meet with the City of Lowell Health Department.
- **There is no \$100 deposit fee. If my booth area is not clean according to the Board of Director's discretion, I will not be allowed to participate in next year's festival.**
